

KIRŞEHIR AHI EVRAN ÜNİVERSİTESİ

Prerequisites, Accepted Exams, Student Quotas, and Application Documents for AHİYÖS Application and Program Preferences

The following documents are required for the application:

1) Candidate Application Form

The form is published on the university's website and should be filled out online by the candidate. Any inaccuracies or omissions in the information and documents entered into the form are the sole responsibility of the candidates.

2) High School Diploma and Turkish Translation

The original high school diploma and its translation (in English or Turkish) should be uploaded. For candidates who have not yet received their diplomas, an official provisional graduation certificate, certified by a notary public or Turkish foreign missions, indicating the expected graduation date, must be uploaded.

3) Passport and Turkish Translation / Turkish ID Card / Blue Card

The photo page of a valid passport should be uploaded to the application form. Turkish citizens (as specified in Article 4, Paragraph 1, Subparagraphs c and ç of this Regulation) should upload a copy of their valid ID card, while Blue Card holders should upload an image of their Blue Card.

4) Exam Fee Receipt

Candidates must upload a receipt showing that they have paid the exam application fee. The exam application fees paid by candidates for AHİYÖS cannot be transferred to subsequent years. The application of a candidate who does not pay the exam application fee is considered invalid. Fees will not be refunded for candidates who withdraw their application after payment, overpay, have their application considered invalid, do not attend the exam, are not admitted to the exam, fail the exam, or have their exam invalidated.

5) The TRYÖS result document valid for additional placement must be uploaded to the online application system.

Prerequisites for Program Preferences, Accepted Exams, Student Quotas: Accepted exams for application are AHİYÖS and TR-YÖS.

Only one of the AHİYÖS and TR-YÖS exam types can be used for the application.

1) Meeting the requirements and obtaining the minimum score in either one is sufficient for the application. Only AHİYÖS scores are valid for the initial placement, and both AHİYÖS and TR-YÖS scores are valid for additional placements.

2) When evaluating TR-YÖS scores, the conversion to a 100-point scale is considered. If the result falls between 100 and 500, 20% of the TR-YÖS score is taken into account.

3) In case of equal scores, the applicant who applied with AHİYÖS has priority over the applicant who applied with TR-YÖS.











4) AHİYÖS is valid only for the year it is taken, while TR-YÖS is valid for two years.

5) To apply for programs that admit students through a special talent exam, it is necessary to have a valid score in at least one of the accepted criteria. Other requirements for these programs, including the date, time, and evaluation process of the special talent exam, will be announced on the relevant department's website.

6) Exams conducted by other universities for YÖS (Foreign Student Examination) are not accepted, except for AHİYÖS and TR-YÖS.

7) The evaluation of applications and the placement of candidates are entirely the responsibility of Kırşehir Ahi Evran University. Meeting the application conditions does not guarantee admission to a program or department.

8) The quotas for international students to be accepted from abroad for each academic year are determined by the Rectorate and submitted for approval to the Council of Higher Education (YÖK). The university is free to fill or not fill the announced quotas.

9) AHİYÖS will only be held at Kırşehir Ahi Evran University in Turkey, and the AHİYÖS exam will be conducted at locations designated by our university in countries where a sufficient number of student applications have been received.

10) AHİYÖS exam applications are accepted only through the online registration system, and pre-registration or pre-acceptance by any institution or organization is not accepted.

11) During the admission of international students from abroad, when evaluating student applications, there is no restriction on the validity period of high school completion exams (such as Abitur, International Baccalaureate, GCE, Tawjihi, etc.), but the validity period of university entrance exams (such as SAT, etc.) is limited to two years, as recommended for use in foreign student admissions by universities and approved by the Council of Higher Education.

12) In case the student taking the exam does not meet the requirements for Foreign Student Admission from Abroad, the application will be considered invalid even if the exam results and placement have been completed.
